Individuals being sought for 2007 PTC Officer positions

It is time to start planning and forming next year's team of officers and board members. The active involvement of PTC members is critical for the continued success of PTC programs and can be a valuable experience for those willing to contribute their time and effort to PTC. Interested individuals may cochair all officer positions with the exception of Director-at-Large and President-Elect. In recognition of the work contributed by officers to PTC, officers are not required to pay to attend luncheon meetings or conferences. If two individuals co-chair the office, this benefit is also shared. A description of each officer position is as follows:

PTC Officer Descriptions

Director- At- Large

If you have a good understanding of PTC's mission and goals, and possess a strong background in personnel testing and selection, the Director-At-Large position is for you. All powers of PTC are exercised under the authority of the Executive Board, operationally and legally. The Executive Board approves the annual budget, sets policies for the organization, and takes public positions for the organization. There are nine (9) Executive Board members: six (6) Directors-At-Large, the President, the Past President and the President-Elect.

President-Elect (three-year term)

As President-Elect you will have the opportunity to "learn the ropes" before assuming the Presidency in the following year. The President-Elect presides over PTC events in the President's absences, prepares objectives and a proposed budget for the following year, chairs the nominations committee and votes as a member of the Executive Board. Upon assuming office of President, the incumbent is responsible for presiding at PTC events, appointing committee chairs, implementing Board-approved programs and expenditures, and approving programs and related activities. In the third year of term, the person becomes Past President and remains a voting member of the Executive Board.

Vice President - Programs (one-year term)

The Vice President for Programs generates ideas for speakers and arranges for speakers at the nine regular monthly luncheon meetings. In addition to introducing the speakers, the Vice President presides at meetings in the absences of the President and President-Elect.

Vice President - Conferences (one-year term)

The Vice President for Conferences arranges the program for the Spring and Fall Conferences, including developing the program concept, arranging for speakers, determining the location and arranging social activities.

Vice President - Publications (one-year term)

The Vice President for Publications obtains material, edits and publishes the PTC newsletter and all other PTC publications. The VP for Publications must distribute publications to the members of PTC.

<u>Vice President – Web Page (one-year term)</u>

The Vice President for Web Page is responsible for designing and maintaining the PTC Internet website. The Vice President ensures the information on the website is current and accurate. In addition to making content modifications, the VP of Web Page can also change the design and functions of the web page, as needed.

<u>Treasurer (one-year term)</u>

The Treasurer keeps all financial records and is responsible for all moneys, and deposits them as approved by the Executive Board. The Treasurer pays all bills and collects payment for PTC events; bills and receives dues from members; prepares and submits periodic reports to the Executive Board; and is responsible for filing PTC's tax returns.

Secretary (one-year term)

The Secretary maintains mailing lists of current members, Board members and officers; prepares and distributes to paid members a current copy of the Membership Directory and bylaws; mails PTC announcements to members, Board members and officers. The Secretary also records and distributes minutes for the Executive Board and officer meetings.
