I. Motion

Joan Stiegelmar put forth a motion on October 15, 2013 to vote on whether PTC-SC should sponsor CSPCA for up to \$600.

- The majority vote was to give the speakers of the conference \$50 gift cards to Amazon (Eliana Ceja: Please purchase 5 cards for the conference).

NEW BUSINESS:

CSPCA sent me an email about sponsoring their conference in Feb. 2014. Since they need an answer before our next board meeting, I am putting this out for a vote. Here are the options:

- 1. \$500 Sponsor name and/or logo on conference badge lanyard for attendees
- 2. \$600 Exhibitor, with one 6' x 30" draped table, and complimentary meals for one person all functions (a \$250 value)
- 3. \$500 Half Page Advertisement only on the on-site final program
- 4. Up to \$600 Let the "new" board decide

Last year we paid \$500 for the CSPCA sponsorship and I was the complimentary attendee as the PTCSC President for 2013. The conference is in San Jose on Feb. 6-9, 2014. PTCSC would not be responsible for travel and lodging for the attendee, and my thought is that first "dibs" should go to the 2014 President of PTCSC, Amy Tompkins.

I am recommending that a motion be made to sponsor the CSPCA Conference up to \$600. After our board is elected into office and announced on November 15, the board can figure out if Amy, or any other board member, is attending the conference. If a board member is going to attend the conference, then PTCSC can sponsor for \$600, but if no board member is attending, then sponsor for only \$500. Please choose Option 1, 2, 3, or 4.
